X Status for Program-Level Reporting Only*

**X status is not available at the campus level*

An X status is used to indicate a student that was NEVER ENROLLED in a particular program. This functionality allows schools to inactivate or “erase” program data previously reported incorrectly. One of the most common examples is reporting a student under a CIP code for a program that they never attended. Please note, however, that although this is the most common scenario, the X status can be used to correct any number of program-level field errors.

The Clearinghouse’s definition for a unique program is consistent with the *NSLDS Enrollment Reporting Guide* and uses the following fields:

- OPEID
- CIP CODE
- Credential Level
- Program Length (a combination of the Number of Weeks in the Title IV Academic Year, the Published Program Length, and the Program Length measurement)

- X status enables schools to correct program-level data previously sent incorrectly
- Because 150% reporting requirements emphasize the critical nature of program-level information, the X status plays a critical role in allowing schools to edit this data to ensure accurate subsidy calculations
- Formerly, when schools needed to correct program-level information through the Clearinghouse, they leveraged the withdrawal and reenroll functionalities. The Clearinghouse recognized that this is not the most accurate way to capture changes to erroneously reported information and, as a result, added X status to the available program-level reporting status options.

How to Report an X Status at the Program Level via Online Update

There are four options for updating program information:

1. Add New Student: Only available if the student has not previously been reported by your school
2. Update Program Indicator and/or Program Information: Available if student is currently enrolled
3. Re-Enroll Student
4. Other Changes: Available if student is currently enrolled or has previously been reported as Withdrawn or Graduated

To “X” a student from a program where one of the defining fields above was reported in error, you should:

- Report the same program again (although you may need to add it, if the program in question is not on the student’s current record)
- Change the Program Status field to “Never Attended,” which is the X status
- Set the Program Status Effective Date to match the Program Begin Date

In our example, program CIP 390501 was reported in error. **The correct CIP must be added to student record.** Although only the CIP code field is incorrect, changing its value creates a new and unique program, per NSLDS, because it is one of the five elements that triggers a new program identification.

To avoid creating a new program with an X status, the **original program must be re-reported with: 1) exact same identifiers, 2) status changed to Never Attended, and 3) Program Status Effective Date set to match the Program Begin Date.** (Once Never Attended is selected, the Program Status Effective Date will be updated to match the Program Begin Date and then disabled, see the note below.)

NOTE: When you change the status to Never Attended (which is the X status), the Program Status Effective Date is updated automatically, if it is different than the Program Begin Date. Program Status Effective Date is then disabled and you will see the message below.

Program Status Effective Date field has been disabled as you've indicated that the student has never attended this program (X status). Per guidelines the Program Begin Date and the Program Status Effective Date must match, so the PSED has been automatically updated.

In addition, a **SECOND program with the correct CIP must be added**. When reported to NSLDS, this will eliminate the program with the incorrect CIP and keep the newly reported program with the correct CIP.

Click Submit to send the correction, which will be reviewed and loaded to the Clearinghouse database by our School Operations staff.

In this second example, the program was reported with a 400000 (400) Year Program Length and must be corrected to a 004000 (4) year Program Length. Again, per NSLDS, changing this value creates a new and unique program, therefore, **the original program must be re-reported with the exact same identifiers**, including the 400000 Published Program Length. However, the status should be changed to Never Attended and the Program Status Effective Date set to match the Program Begin Date.

NOTE: Once a correction is completed and loaded to the Clearinghouse database, the X status program may not be reflected and some program fields may not be visible, when you log in to view a student's information. For example, you may see program 1 and program 3, but not program 2 OR the programs may appear in a different order than they were submitted. This is done to eliminate the possibility of the same bad program being updated multiple times.

X status can also be reported within an enrollment submission, but the same rules apply: You should identify the WRONG program information with an X status and add a 2nd program to provide the corrected data.
